## ENTRIES DUE BY MARCH 5, 2010

The Indiana YMCA State Swim Meet is located at Summit Middle School:

4509 Homestead Rd.

Ft. Wayne In, 46814

**Format:** The meet will be concluded over 5 sessions. Friday evening, Saturday morning, Saturday afternoon, Sunday morning, and Sunday afternoon.

**Facility:** The facility is an indoor 25 yard pool. Automatic touch pad timing and scoreboard will be used.

**Event:** Each swimmer may compete in a maximum of eight individual events during the entire meet, with no more than 4 individual events per day. Swimmers 8 and under may swim in no more than 6 individual events, with no more than 3 per day.

**Event order:** A complete zip file of the meet will be attached with this file. In general 10 and under will compete in the morning sessions and 11 and over in the afternoon, longer events being held on the Friday night.

The 1650 will be held between the morning and afternoon sessions. The girls will be held on Saturday and the boys on Sunday.

**Scoring:** For both individual and relay events, the scoring shall be for the top sixteen (16) places.

Individual events: 20,17,16,15,14,13,12,11,9,7,6,5,4,3,2,1

Relays: 40,34,32,30,28,26,24,22,18,14,12,10,8,6,4,2

**Awards:** Individual and Relay events will receive Medals 1<sup>st</sup> through 6<sup>th</sup> place finishes, and 7<sup>th</sup> through 24<sup>th</sup> place finishes will receive ribbons.

**Entry Fees:** Team fees will reflect the following:

\$1.50 surcharge per swimmer.

\$3.50 for each individual event entered

\$12.00 for each relay entered

Deck entries will be accepted, only in available lanes at the following fees:

\$1.50 surcharge (if not already entered in meet)

\$7.00 per individual event

\$20.00 per relay

The total fee needs to be paid before the first event on March 12<sup>th</sup>.

**Entry Format:** All teams need to enter swimmers with yard times. The entries should be sent via e-mail in either meet manager or team manager format.

**Deadline:** All entries are due before midnight on March 5<sup>th</sup> 2010. They are to be mailed to the following address, any entries received after this time will be charged an additional \$50.00 **fee**.
